

The eligible students may apply through online on the website of common National Scholarship portal of Govt. of India under URL [www.scholarships.gov.in](http://www.scholarships.gov.in) as per above given time line. It may also be ensured that the student will take printouts of the duly filled application forms and submit along with all supporting documents (i.e. residence proof, last class pass certificate, aadhar no., bank account in the name of applicant, income proof, minority certificate/affidavit) in their respective institutes. Institutes are suggested to verify the applications of the students on NSP portal using their Institute use ID AND Password, well in time.
